Fraud Flash -Fraudulent Job Offers

Fraudsters are quick to take advantage of people looking for new employment opportunities. They will use the prospect of income to deceive others without their knowing.

To be convincing, they pose as recruiters for well-known companies. They post messages on job posting websites, such as <u>Indeed.com</u>, and tell people that they have the qualifications they are looking for in a new job. Once people are interested, they'll forward job duties and benefits and conduct an interview, usually virtual, to persuade them to accept.

Once "employed," these recruiters can

- Ask for personal information (SSN, account number, etc.) or money to complete their employment. They then disappear with these resources to commit identity theft or other crimes.
- Send a bill for office equipment or supplies and ask for payment using cash, gift cards, or payment transfer services like Zelle. Victims send the money but never receive the equipment or supplies.
- Under the guise of "quality control," send victims several merchandise and ask them to dispose of the original box, repackage, and ship to another address. This merchandise is stolen, and fraudsters want others to hide this nature by repackaging it as legitimate.

To avoid these scams, never give out personal information or money upfront, and make sure the job position is legitimate with the company. Research the company in more detail and contact it through official phone numbers.
