Hackers will sell entire stolen databases of personal information, and fraudsters will use this information to launch their own scams or cyber-attacks.

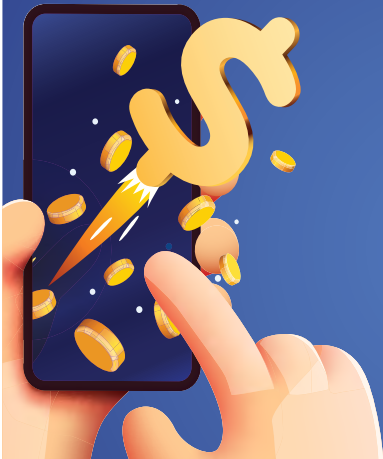

Constella Intelligence will scan the dark web for your personal information. If it's found, you'll be alerted of where the breach occurred, if your password was stolen, and what you should do, such as changing your password.

Haven't made a transaction to your account in a while?



According to state regulations, any account that is dormant, which means no account activity for a set number of years, must be reported to the state. WEPCO sends out two notices each year, July and October, to notify any member if their account has fallen into dormancy.

If you have received a notice, simply complete the bottom of the notice and return to WEPCO or complete a transaction on your account. If no action is taken, the money in the account is remitted to the state. If you have any questions about dormancy, please contact us today.

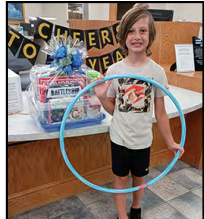
